ADDITIONAL TERMS

Program Conditions

1. 'All times noted in these Terms and Conditions are local times, based on the location of the Promoter. Applications must be received by the Promoter prior to the competition close date and time.
2. Applicants who are to be named Winners of the Grant Program accept and agree that the Organisation may be filmed during a potential Surfing Australia visit, for a content series produced by the Promoter and Major Prize Supplier ('**Filming**').
3. The Promoter and Major Prize Supplier may promote (and the Applicant acknowledges and agrees) information about the Winners or Runners Up on various channels of the Promoter and/or Major Prize Suppliers media and communication channels as well as in club related marketing material for an indefinite period. This may include Filming, holding presentation ceremonies and other media events.
4. The Promoter and Major Prize Supplier will have full and sole ownership and rights and usage of any imagery or content captured through the application process, Filming and presentation to the Winners and Runners Up and any imagery or content provided by the Organisation or the Applicant in relation to the Application, Program or the Organisation's activities.
5. Applicants who are to be named as Winners and recipients of a cash prize under this Program, may be required to sign an agreement with the Promoter and the Major Prize Supplier on terms reasonably required by the Promoter and by the Major Prize Supplier as a precondition of them being so named. The contract would ensure that the grant money being rewarded to the Boardrider club would only be allowed to be used to benefit or improve the Boardrider club and that if they club was to be found not using the money in the correct manner there would be a breach of contract.
6. Any financial assistance provided by the Promoter in relation to the Program is considered a donation and is provided exclusive of GST regardless of the recipients GST registration status.
7. The Promoter may vary the method of payment of the grant at its sole discretion.
8. The grant recipient must repay the full relevant part of the granted funding to the Promoter with 14 business days after it receives formal notification from the Promoter if the Promoter has overpaid the grant recipient.
9. The Promoter retains absolute discretion to determine the prize category to which an Applicant or Organisation may be entitled. An Applicant is only entitled to win one (1) Prize in 2020. The Promoter may also ask the



successful Applicants and Organisations to execute an acknowledgement setting out the use of any grants or prizes, and promotional activity as a condition of receiving a grant under the Program.

Further Terms and Conditions

10. All Winners acknowledge and agree that in the event that the Application Form is successful, the Promoter with Surfing Australia and boardrider club approval may use all information contained in the Application Form for conducting further research, evaluation and development of resources in relation to Boardrider clubs and the Program.
11. Any entrant found to be entering incorrect contact details or using a third party to apply on their behalf will have all entries invalidated and any claim they have to any prize will be invalidated. If such an entrant is awarded a prize and then found to have breached this clause, the entrant must immediately return any prize awarded. The Promoter has sole discretion to determine if this clause has been breached by any entrant. The Promoter reserves the right to request whatever documentation it deems necessary to confirm if the entrant has breached this clause. An entrant must provide any requested documentation to the Promoter upon request. The Promoter reserves the right to disqualify any entrant who provides false information or who seeks to gain an unfair advantage or to manipulate this competition.
12. The Promoter reserves the right to request winners to sign a winner's deed of release (and indemnification) or any other relevant forms or agreements that the Promoter deems necessary, to provide proof of identity, proof of age, proof of residency at the nominated prize delivery address and/or proof of application validity (including phone bill) in order to claim a prize. Proof of identification, residency, age and application considered suitable for verification is at the discretion of the Promoter. In the event that a winner cannot provide suitable proof, the winner will forfeit the prize in whole and no substitute will be offered.
13. The Promoter reserves the right to choose an alternative winning application in the event that an entrant, claiming to be a winner, is unable to satisfy these Terms and Conditions or has breached these Terms and Conditions.
14. The Promoter's decision in relation to any aspect of the competition is subject to State and Territory legislation but also final and binding on each person who applies. No correspondence will be entered. No responsibility is accepted for late, lost or misdirected entries. Prizes are subject to availability, not transferable or exchangeable and, with the exception of cash prizes, cannot be taken as cash. These Terms and Conditions are governed by the laws of New South Wales and each entrant agrees to submit to the non-exclusive jurisdiction of the courts of the State.

Privacy Collection statement

15. By submitting an application into this competition entrants consent to receive promotional and other marketing messages from the Major Prize Supplier and the Promoter with the approval of Surfing Australia and Boardrider Clubs. Entrants will be able to opt-out at any time by following the instructions included in each message sent by the Major Prize Supplier and/or the Promoter.
16. The Promoter and its related entities collect entrants' personal information ("PI") for the purpose of conducting and promoting this competition (including but not limited to determining and notifying winners). The Promoter may disclose PI collected to an agent who is engaged to conduct the competition Selection and for prize fulfilment. The Promoter may also disclose PI collected to Australian regulatory authorities, such as the regulators of trade promotions. Application is conditional on providing this PI. The Promoter and the Prize Supplier will otherwise handle your PI in accordance with their Privacy Policies available at www.surfindustralia.com/freshgrant. The Privacy Policies also contain information about how entrants may opt out, access, update or correct their PI, how entrants may complain about a breach of the Australian Privacy Principles or any other applicable law and how those complaints will be dealt with. All entries become the property of the Promoter.

Copyright, Statutory guarantees, Waiver and liability

17. All entries and any copyright subsisting in the entries become and remain the property of the Promoter only during the Fresh Grant campaign period and only in association with Surfing Australia. The Eligible Entrant accepts that the Promoter and/or Major Prize Supplier may publish or cause to be published any of the entries received on, but not limited to, social media channels and website advertising. Where this is the case, Boardrider Clubs will be notified and given opportunity to approve use of entries.
18. In participating in the prizes, the Winners agree to participate and co-operate as required in all editorial activities relating to the Competition, including but not limited to being filmed during a club visit, using the winning application, being interviewed and photographed during the Fresh Grant campaign period and only in association with Surfing Australia. The Winners (and their companions) agree to granting the Promoter a perpetual and non-exclusive licence to use such the uploaded photo, footage and photographs in all media worldwide, including online social networking sites, and the Winners and Runners Up (and their companions) will not be entitled to any fee for such use. Where this is the case, Boardrider Clubs will be notified and given opportunity to approve use of entries.

The Promoter (subject to State and Territory legislation) reserves the right to amend, cancel or suspend this competition if an event beyond the control of the Promoter corrupts or affect the administration security, fairness, integrity or proper conduct of this competition. The Promoter will disqualify any individual who has tampered with the application process or any other aspect of this competition. In particular, computer generated entries and the use "scripting" is not permitted and will not be accepted.

Nothing in these Terms and Conditions limit, exclude or modify or purports to limit, exclude or modify the statutory consumer guarantees as provided under the Competition and Consumer Act 2010 (Cth), as well as any other implied warranties under the ASIC Act or similar consumer protection laws in the State and Territories of Australia (**'Non-Excludable Guarantees'**).
