Safer Internet Day is a global day of action that brings together industry, workplaces, communities and schools from more than 180 countries to raise awareness of online safety issues and work towards a safer internet.

In Australia, the eSafety Commissioner leads this important day and this year, we're calling on all Australians to **help make the internet a safer and more positive place.**For industry, Safer Internet Day is a great opportunity to reflect on their role in online safety. It serves as a reminder to promote the benefits of designing and developing safe online spaces – on Safer Internet Day and beyond.

Why is Safer Internet Day important?

The digital world touches every aspect of our lives, and our research demonstrates the very real dangers of the online world, especially for young people.



70% of Australian adults have had at least one **negative experience** online*



29% of First Nations children have experienced online hate speech*



45% of kids aged 8-17 have been treated in a hurtful or nasty way online*



32% of gamers aged 8-17 have been **bullied** while playing games online*



31% of LGBTIQ+ teens have experienced hate speech online*
