

# NRMA Insurance RISE "New Women's & Girls' Boardrider Club Experience" Surfing Australia Competition – Terms & Conditions

#### 1. Acceptance of Terms

Entry into this competition is deemed acceptance of these Terms and Conditions. Information on how to enter forms part of these Terms and Conditions.

#### 2. Eligibility

Entry is open to newly established women's and/or girls' Boardrider Clubs located in Australia that are officially registered or in the process of registering under the NRMA Insurance RISE program and "Play Our Way" grant initiative. To be eligible, clubs must:

- Be newly formed in December 2025 March 2026 and specifically created to support women's or girls' surfing participation and development.
- Complete the official NRMA Insurance RISE Program affiliation process during the Competition Period.
- Be able to verify club details and contact information upon request.
- Employees, directors, and contractors of the Promoter, its related entities, and their immediate families are ineligible to enter.

#### 3. Promoter

The competition commences on **Monday 8**<sup>th</sup> **December 2025** and closes on **Tuesday 31st March 2026** ("Competition Period").

Entries received outside this period will not be accepted.

#### 5. How to Enter

To enter, eligible clubs must, during the Competition Period:

- a) Sign up as a **new women's & girls' Boardrider Club** under the NRMA Insurance RISE Program and the "Play Our Way" initiative via the official affiliation process; and
- b) Complete all required registration details.

Entry is limited to one entry per registered club.

#### 6. Game of Chance

This is a game of chance. The winner will be selected at random. Chance plays the entire role in determining the winner.

### 7. Draw & Winner Notification

The draw will take place on **Tuesday 7<sup>th</sup> April 2026** at **the Surfing Australia Hyundai High-Performance Centre.** 

The winning club will be notified via email and/or phone by Tuesday 7th April

#### 8. Prizes

Scheduled for **June 2026** (exact dates to be confirmed by the event organiser). Entry covers one team representing the winning club.

Travel & flights to and from the Seas The Day Festival are not included and are the responsibility of the winning club and participants.

# Four (4) Entries to the NRMA Insurance RISE Development Camp (Scheduled May 2026) (Casuarina NSW)

Includes:

Return economy flights for **four (4) participants** from the winners' nearest capital city to the event location.

Accommodation for two (2) nights for four (4) participants.

All official NRMA Insurance RISE Development Camp inclusions.

If flights are not required by the winner (e.g., participants reside locally), this component of the prize is forfeited and cannot be redeemed for cash, credit, or an alternative benefit.

The prize does **not** include flights for the Seas The Day Festival; all travel to/from this event is the responsibility of the winning club.

Travel must be taken on dates specified by the Promoter; no alternative travel dates are permitted.

Flights and accommodation are subject to availability.

Participants are responsible for all ancillary costs not expressly included (meals, baggage fees, transport, insurance, incidentals, etc.).

Participants must comply with all airline, accommodation, and event provider terms.



#### 10. Event Changes, Cancellations & Travel Disruptions

If any included event (NRMA Insurance RISE Development Camp or NRMA Insurance Seas The Day Festival) is postponed, cancelled, or changed for reasons outside the Promoter's control, no cash alternative or replacement event will be provided.

The Promoter accepts no responsibility for airline delays, cancellations, missed flights, or failure to attend events due to travel disruptions.

If flights for the NRMA Insurance RISE Development Camp cannot be rebooked or used for any reason, the flight component of the prize is forfeited and cannot be exchanged for cash or substituted.

#### 11. Verification

The Promoter may verify club registration details and eligibility. Entries may be disqualified if false, incomplete, or unable to be verified.

#### 12. Intellectual Property & Permissions

By entering, the winning club grants the Promoter the right to use the club's name, logo, and any related media for promotional and marketing purposes relating to this competition and the NRMA Insurance RISE program.

#### 13. Liability

Nothing in these Terms limits statutory consumer rights under Australian Consumer Law. Except for liability that cannot be excluded, the Promoter is not responsible for any loss, injury, damage, or claims arising from:

- attendance at events
- flights or travel
- participation in the development camp
- use of the prize
- changes, delays, cancellations or unforeseen circumstances

#### 14. Privacy

The Promoter collects personal information to conduct the competition and award prizes. Without this information, entries may be invalid.

By entering, entrants consent to their personal information being used for the purposes of administering the competition and contacting them about future Surfing Australia programs, competitions, or promotions (unless they opt out).
